New London Business Block Was Afire At Two O'clock

Fire which broke out in the grocery store of C. F. Rowland at New London at midnight destroyed the Ralls County Times office, the grocery store of A. G. Kennedy, the moving picture show of Woods & Weaver, the Park Hotel and Dick Edding's barber shop.

The loss will amount to between \$35,000 and \$40,000. The fire was discovered by Miss Mary Pritchett, daughter of Sheriff Pritchett and she notified her father, who fired his revolver and aroused the town. The citizens worked heroically and kept the fire confined to the one block.

Mrs. Wood owned three of the buildings destroyed, she carried some insurance. A. G. Kennedy carried \$2,600 insurance, the picture show was insured for \$600. No insurance on hotel. Fisher & Harris carried \$4,000---Thursday morning Hannibal Journal

Perry Enterprise February 8, 1923 3 New London Stores burn

Hannibal Fire Department Called, Loss Estimated Near \$10,000.

New London, MO, Feb, 2 - A fire, which for a time, threatened an entire block on Main Street in New London's business section last night destroyed three buildings, resulting in a loss estimated at nearly \$10,000.

The flames became so menacing that a call was made on the Hannibal department and Chief T. B. Parks and a force of fire fighters rushed here with an engine and aided in checking the spread of the conflagration. The big engine was fed from a large cistern of the Christian Church which was pumped dry while the flames were being extinguished.

The fire was discovered in the grocery store of Owen Briscoe at about 7:15 o'clock. The first flames were near the center of the building and no one seems to know just how the fire originated. It has been suggested that some person must have dropped a cigarette on the floor shortly before the store closed at 6 o'clock.

The grocery is what is known as the Steve Newlon building and O. D. Helms and family lived on the second floor. The fire quickly spread to the barber shop of Mr. Helms next door and the offices of Dr. S. Ragan above. Both these buildings were destroyed and a one-story structure occupied by G. E. Yager's hardware store north of the grocery was wrecked when the brick wall of the Briscoe store fell on it. Mr. Yager had removed much of his stock while the adjoining building was burning but all that remained inside was destroyed when the wall gave way.

The building occupied by the barber shop was owned by Mrs. J. R. S. McCune, of Bowling Green; the grocery by J. L. Smith and the hardware store by Mrs. Mollie Fell. The amount of insurance was not ascertainable today but the loss was partially covered.

The Hannibal department made the run in a half hour and did excellent work after arriving. Attaching its hose to the cistern at the Christian Church, the big engine was put into action, and the firemen worked for an hour. Local people congratulated Chief Parks on the department's work.
